### The Sentinel Interviews The Printz: Commissioner Candidate

It was a most special experience witnessing the interview of Mr. Jay Printz running for District 2 County Commissioner by Mr. George Gramlich, Managing Editor of the Sangre de Cristo Sentinel. For over an hour the engaging exchange, between two of the main movers of the Wet Mountain Valley area, was a fascinating display of open and honest dialogue. With no holds barred, it was an eye opening conversation that revealed a shared interest in the long term well-being and advancement of Custer County as a whole. It started with a bang as Mr. Printz stepped into the office of the Sentinel and, with a rap on Mr. Gramlich desk, asked "What can I do for you and the readers of your paper". With that, the discourse was on.

Describing himself as a "conservative Republican" Mr. Printz expressed his deep respect and high regard for The Constitution referring to it as an "unbelievably fabulous doc-

ument" which has been changed, by amendments, only twenty-seven times since 1787. By following it, he continues, you have a good and orderly government. To a series of queries from Sentinel's editor, many of which were called in or sent by Sentinel readers, he acknowledges that he may have been tagged as too liberal due to some positions he has taken as a lawyer for certain Custer County businesses/entities. He defends himself effectively by citing the fact that his profession, as attorney at law, obliges him to defend client's positions which he might not personally espouse, but, to do a good job for the client, needs to present convincingly. However, he is careful to make sure that he is understood that, while being a Republican, he is not going too far to the right either, reiterating his preference to remain, strictly, within the tenets of The Constitution and quickly establishing his support of the Second Amendment and not for Obamacare. However, he feels that af-

fordable healthcare is absolutely essential for all American citizens. He also said he was opposed to the unconstitutional gun laws passed two years ago by Colorado democrats (especially the 15 round magazine limit). Responding to a question from the Editor concerning national politics, Mr. Printz responded that his favorite Republican candidate for President is Ted Cruz.

Born in Brooklyn, New York, and raised in Connecticut, Mr. Printz did his undergraduate studies at the University of Oklahoma where he took up political science. He spent some time in New Orleans, Louisiana, before ending up in the Lone Star State of Texas in both Houston and Fort Worth. With an MBA from the University of Dallas he ventured into the oil and gas industry successfully running a company for twenty years. He became a lawyer as he says "late in life". Actually, he was a young man of fifty when he got his degree at Texas A & M. He has been in Westcliffe not

quite ten years, owns and operates the pawn shop, Loan-A-Ranger, on Main Street, Westcliffe, and lives in nearby Rosita.

As far as running for Coun-

ty Commissioner is concerned, Mr. Printz is very clear in his mind as to what his vision is. In fact, it is quite simple. As he sees it, the job is to manage efficiently many real or perceived needs on a modest budget. With the extensive experience of running successful and profitable companies over long periods of time, he confidently approaches the commissioner position with a clear concept of what needs to be done for the county to, not only operate efficiently, but to thrive and prosper. After more solicitations from the editor, Mr. Printz offhandedly ventured some ideas that may be considered such as, giving incentives to businesses (local or from out of the county) to operate in the area, short term SBA type loans from the local bank to induce new ventures and productivity, maybe a much needed phar-

### **Charges of Animal Cruelty in Westcliffe?** Not Exactly...

On Tuesday, the West-cliffe Municipal Municipal Court was called to order by Judge Rebecca Casey to hear the case of the defendants who had been arraigned on charges of having failed to adhere to town ordinances regarding their five dogs. While the actual citations regarded barking dogs, the town authorities have received numerous complaints alleging animal abuse and neglect

The actual defendant was the lady who was seated front and center at the packed room: Ms. Darlene Schuetz. In fact, all seats

were taken and there were at least a dozen people standing along the walls and in the hallway to hear about this emotionally charged issue.

The judge started off by explaining the proceedings and reminding people that this is a court of law and not a public forum. At the end of her opening statement, the judge asked if the defendant wanted to continue the hearing or if she would like to postpone. She was also advised that she could get her own lawyer. In this particular case, since it was not a criminal trial with the possibility of a jail sentence, the court could not appoint legal counsel. At that point the defendant stated that she wanted to have the hearing immediately and pleaded "Not Guilty".

Mr. Jay Printz, the town attorney for Westcliffe represented the Town.

After nearly four hours, the defendant was found guilty and ordered to pay fines to taling \$900, which may be suspended if they rehome four of the five dogs by next Tuesday. Ms. Schuetz stated her intentions for appealing the decision.

on any raise although he felt that some of other elected officials deserved some raise. As for the health benefits he would not accept that either which would be additional savings for the county. He stands firmly on strict fiscal accountability as far as public money is concerned; money from taxpayers hard earned work should never fund any private enterprise.

Other topics touched on in the discussion were the current attempted end run around TABOR by Colorado democrats (trying to prevent a tax refund for us), the Custer County Clinic's management, future and finances, and the possibility of having a county administrator to help centralize purchases and services and lower the cost thereof.

As the interview was wrapping up, Mr. Printz reiterated that he is running for ALL the residents of Custer County.
