Rules and Regulations

The Trout Ranch/Cross D Bar Recreation Foundation

A. PARTICIPATION

- 1. Entry form must be submitted for each entry or group and each participant must sign and date the attached Release and Waiver of Liability Agreement.
- 2. Entry forms should be returned by 4 P.M. Monday May 21 to the Sentinel, 601 Main Street, Westcliffe, CO 81252.
- 3. The Parade Committee will review all applications and reserves the right to accept or reject any entry.
- 4. All entrants must be modestly and appropriately dressed.
- 5. Children under 16 years of age must be accompanied in the parade by a parent or adult.
- 6. All entries should report to the parade staging area (Hermit Lane by the Mining Company) at least one hour prior to Parade start time.
- 7. This is a Memorial Day Parade. Any entries deemed inappropriate by the parade sponsors will be rejected.

B. SAFETY

- Absolutely nothing may be thrown out to spectators from motorized vehicles, horse-drawn vehicles or riders on animals. Distribution of candy or pamphlets may be made by walking individuals only and must be handed NOT thrown to spectators. Participants are urged to consider the safety of spectators and parade participants and prevent spectators from entering the parade route during the parade.
- 2. Each entry shall exercise all precautions for the safety of others and be responsible for their own animals, vehicles, floats, etc.
- 3. Consumption of alcoholic beverages by participants during line-up or parade march is strictly prohibited.
- 4. To assist sponsors in properly and safely lining up entries for parade, entrants must list whether animals, sound effects or loud noises will be used.
- 5. Discharging of firearms containing live or blank ammunition is prohibited.
- 6. Directions issued by parade officials and/or law enforcement officials shall strictly be observed.
- 7. All entrants must remain in the parade to the end of parade route.

- 8. No one may get off or on any vehicle, float or trailer while on the parade route, even if the vehicle is stopped.
- 9. No semis, pickup-trucks only. (exception for military and fire department)
- 10. Firearms Safety Protocol: All long guns (rifles, shotguns, muskets, stinger missiles, RPG's etc.) must be shouldered with a sling. All long guns must be unloaded with the safety on. No detachable magazines are allowed to be inserted in a long gun. Chamber flags are encouraged. No ammunition is allowed to be on or in any long gun. No handling of firearms allowed. Handguns must be holstered with any applicable safeties on. All firearms are subject to inspection by the parade sponsor. Minors who are in the direct and immediate supervision of a parent or adult legal guardian may carry a long gun in accordance with all rules stated and in accordance with all Colorado laws.

C. GENERAL

- 1. All entries are expected to report to designated line-up position ready to participate no later the ½ hour before parade start time. Entries, which are not in designated position, may be disqualified or moved to end of parade line up.
- 2. Participants should be dropped off within walking distance of their designated entry position. Non-parade vehicles will not be allowed into the parade line-up area to drop off participants. Parking and pick up areas will not obstruct the parade line-up area.

D. ANIMAL AND HORSE DRAWN VEHICLES

- 1. Outriders are <u>required</u> for all saddle clubs, mounted groups and animal drawn vehicles.
- 2. Safety of participants and animals is important. Not all animals are comfortable with crowds, noises, fluttering flags, balloons and kids along route and increased activity. Participants are solely responsible for the control of their animals in the parade and shall immediately attend to animals that exhibit a tendency to spook or become uncontrollable during parade
- 3. No children under the age of 10 will be allowed to ride animals in the parade without an accompanying adult. (Adult may walk or ride).

I. Release and Waiver of Liability

In consideration of being permitted to participate in the Memorial Day Parade sponsored by the Sangre de Cristo Sentinel and the Trout Ranch/Cross D Bar Recreation Foundation on May 26, 2018, line up at 9 a.m. parade starts at 10 a.m. ["The Parade"] the undersigned hereby acknowledges, represents and agrees as follows:

READ CAREFULLY BEFORE SIGNING

1. RELEASE AND WAIVER OF LIABILITY

- A. The undersigned understands and acknowledges (1) that the parade may involve animal, motorized and animal drawn equipment; (2) that animals can exhibit unpredictable behaviors that may result in unforeseeable personal injury to participant and/or loss or damage to property; (3) that participation in the parade may involve risk of personal injury or loss or property damage to property; (4) that such risk may arise from a variety of foreseeable and unforeseeable events and circumstances.
- B. By signing this Release and Waiver of Liability Agreement, I hereby expressly assume all such risks of personal injury, loss or damage to property to me or to my child or to any third person arising out of or in any way related to the participation in the parade, whether or not caused by the act, omission, negligence or other fault of the Sangre de Cristo Sentinel, the Trout Ranch/Cross D Bar Recreation Foundation or by any other cause. I further hereby expressly waive, release and discharge the Sangre de Cristo Sentinel and the Trout Ranch/Cross D Bar Recreation Foundation from any and all claims, demands and actions for any such personal injury, loss or damage to property arising out of or in any way related to the participation in the parade, whether or not caused by the act, omission, negligence or other fault of the Sangre de Cristo Sentinel, the Trout Ranch/Cross D Bar Recreation Foundation or by any other cause.
- C. I have read the rules and regulations accompanying the Official Entry Form for the parade and by signing this Release and Waiver of Liability Agreement I hereby expressly waive, release and discharge the Sangre de Cristo, the Trout Ranch/Cross D Bar Recreation Foundation from any and all claims, demands and actions for any personal injury, loss or damage to property arising out of or in anyway related to such Rules and Regulations.
